MINUTES OF RECONCILIATION HEARING

On the twenty first day of September of the year two thousand and sixteen at fourteen o'clock, in the Hearing Room of the 5th Court of the judicial section of PiauÍ, located in the main building, at Av. Miguel Rosa, n ° 7315 - Neighborhood: Redenção Teresina-Pi - Zip Code: 64018-55Q/phone: (86) 2107-2800 / 2801, present the Hon. Federal Judge of the 5th Court, Dra. MARINA ROCHA CAVALCANTI BARROS MENDES, alongside, the Judicial Technician, hereinafter nominated, at the appointed time, the present hearing session was declared open.

Present: The Federal Prosecutor, Dr. TRANVANVAN DA SILVA FEITOSA, The Federal Attorney, Dra. ROSÁLIA TEIXEIRA BEZERRA ADÃO; The Federal Prosecutor, Dr. PEDRO VIEIRA DE SOUSA; The superintendent of IPHAN, FÁBIO JOSÉ LUSTOSA DA COSTA FERREIRA; The Civil Engineer of IPHAN, RICARDO FERNANDES BRITO; The Architect of IPHAN, MARIA CECÍLIA VELOSO LIMA; The Prosecutor of the State of PiauÍ, Dr. KÁTIA MARIA DE MOURA VASCONCELOS; the representative of the Secretary of Culture of the State of PiauÍ, Dr. NELSON ESTEVAM DE ANDRADE JÚNIOR, OAB/PI No. 8.533; The attorney of CMTF, Dr. MARCOS ANTÔNIO DE ARAÚJO SANTOS, OAB/PI No. 2.254/91; The Representative of the CMTF, ANTÔNIO LUIZ CRONEMBERGER SOBRAL. After the proceeding had begun, CMTF presented a counterproposal, in which CMTF would continue in the building until the construction of its main office, according to the floorplan evidenced on page 970, until the construction of its main office, which should take place in the next 10 (ten) years. IPHAN and the Federal Government rejected the proposal, under the argument that the time-period, even if respected, is incompatible with the plans for the usage of the building for historical heritage education. CMTF, therefore, asked the last deadline of 30 (thirty) days to discuss with the Government of the State of PiauÍ the proposal presented at the last hearing session, in which the main points are as follows:

- 1) CMTF will vacate the ground floor of the main building of the Railway Station, so that it can be fully open to the public, to promote the historical and cultural heritage education, through exhibitions, museums and alike, including a thematic room on railroad transport in PiauÍ;
- 2) IPHAN will occupy the 1st and 2nd floors of the main building with offices to perform its administrative activities;
- 3) CMTF will occupy the lateral building, which is composed of the Railway Platform, which should be made available by IPHAN reformed and in conditions of usage;

4) The organization and maintenance of the public exhibition area will of the responsibility of IPHAN.

The Hon. Judge delivered the following DECISION: "I set the last deadline of thirty (30) days, for CMTF to inform, in this lawsuit, whether it agrees with the proposal submitted. During this time period, the proceedings shall be referred to the Federal Prosecutor's Office to present their opinion on the merits of the lawsuit. At the end of the deadline, and without a response from CMTF, or if the response is negative, the proceedings will be sent to judgment. The present parties of this session are considered summoned." Lastly, the hearing session was declared closed. I, _____ Jaira Nádia Carvalho Pereira, designated conciliator, have typed this term which, if read and found to be correct, is signed.
